Dave's report emphasized the progress that the HOA has made in both the physical appearance of the property as well fiscal balance in reserves. 6. Financial Report

Jim Whitis reported that monthly dues will be increased September 1, 2009 by \$2 for the reserve fund to account for inflation. In addition, the dues will be increased \$3-5 depending on the unit model in anticipation of a rate increase by Parker Water and Sanitation.
