#### **Architectural Control Committee –**

Len Price presented ACC report. Weeds are being taken care of by landscapers.

#### Roads & Grounds Committee - Len Price

Landscaping – The landscapers have sprayed for weeds and are now pulling the remaining.

<u>Water Bill</u> – Up \$7,000 from last month. Some used more than 20,000 gallons which sent the bill into the second tier. A building went into the third tier. Notices were sent out to check for leaks.

<u>Rules & Regulations</u> – The Rules and Regs are now done and will be available at the annual meeting in July.

## **Financial Report – Charles**

*Operating Expenses* – We are currently operating at approximately \$96,000 under-budget to date. The water bill may lower that. All other areas are under budget except the pool.

HOA has now paid out \$168,000 so far. \$706,000 has been collected. Some homeowners are in payments, others going into collections. Project should be right on schedule. Monies not collected yet should not impact our ability to pay the contractors. There are 35 homeowners past due- 6 in forclosure, 9 liens, and all others are at the attorney. There is possibly another 6 to be added.

#### Old Business -

The only old business is the painting project. 17% of the project is now done. Steve Bradley coming soon for another walk.

We still have two open board positions, and there will be a third open as of the annual meeting in July. This is the end of Len's term and we are looking for interested homeowners.
