## Let's Keep It In Bounds

As we all know, trash day can get pretty messy with over 500 units. Each member of our community creates about thirty pounds of trash per That means over 30,000 week. pounds of trash are collected from our neighborhood every Wednesday. That can be overwhelming to any trash removal service, and I commend the men who do it for us. And, they do it with almost no complaints.

The only thing I ever hear is the men groaning when they have to carry a heavy trash can up to fifty feet to dump it in their truck. This takes extra time for them and increased the likelihood of a spill. Our regulations state that our trash must be placed no more than five feet away from the curb and there can be no obstructions between our trash and the curb. This means it has to be on the 'curbside' of any transformers, IREA, phone or cable pedestals. This is something that many of us have been getting very careless about.

The rule is in place for the convenience of the men who work very hard every Wednesday morning for our community. They want to pick up our trash as fast as possible, just like we want them to. The easier it is for them to pick up the trash and the less time they have to spend chasing it, the more likely it is we can keep down the costs of our contract. And the less time our trash spends on the corner, the nicer our neighborhood looks.

There are a couple of other issues that we need to keep in mind. The trash removal company will take large items but you need to make prior arrangements with them rather than just piling them outside. They need to make sure that they have the space and time to pick up these large items. You also need to contact them if you have odd things

such as construction debris. If you don't contact them, they won't pick it up. You can't just pile all that stuff outside and it just takes a little common courtesy!! And one last issue -according to our rules and regs, you may NOT place your trash out before 7pm on Tuesday night and your trash cans should be picked up no later than Thursday. We will take the trash can if you leave it out there. If you are unavailable to bring it in, ask one of your neighbors to help you out.

In the near future, the trash disposal company will be painting a line five feet away from the curb. All of our trash should be NEATLY placed on the curbside of this line. The garbage company has told us that we will be fined for any item that is not placed within the specified parameters. I can assure you that these fines will be passed on to the guilty party.

Honestly though, things should not go that far if we all just take the extra couple of steps and get our trash 'in bounds'!!

## **Parker Police Department**

Members of the board met with Dave King, Parker's Interim Chief of Police, on Thursday, November 16. The police department requested the meeting to evaluate their performance and relationship with the Town and Country Village community. In addition, Mr. King asked for any recommendations or requests the board might have to improve either the service or relationship.

Interestingly, the police department employs a crime analyst to evaluate criminal and law enforcement activity in any given area in Parker. They prepared an analysis of Town and Country Village evaluating all police activity in our community from January 1, 2006 to November 15, 2006.

The analysis demonstrated that we live in a very safe community. The bulk of the police activity related traffic offenses. There were a few automobile break-ins, etc., but only two arrests and no violent crimes.

As a board, we appreciate the quality of life we have in Town

and Country Village and the proactive approach taken by the police department to maintain that quality of life. We asked that the department continue to be as visible as possible, especially when school busses unload and during town sponsored events. We urge all who live in the village to be vigilant and aware of any


